Jane Davidson is Pro Vice-Chancellor Emeritus at the University of Wales Trinity Saint David. From 2000-2011, she was Minister for Education, Lifelong Learning Skills, then Minister for Environment, Sustainability and Housing in Wales where she proposed legislation to make sustainable development its central organizing principle; the Well-being of Future Generations (Wales) Act came into law in April 2015. She introduced the first plastic bag charge in the UK, One Planet Developments and legislated on waste which has seen Wales become one of the top recycling countries in the world. She is an associate faculty member at Harvard University and lives on a smallholding in west Wales where each year she aims to live more lightly on the land.
